### 4. First-Aid Measures

## Description of first aid measures

#### General advice:

#### Note to physician

Treatment:

Treat according to symptoms (decontamination, vital functions), no known specific antidote. Anticonvulsant therapy as routinely administered to humans. Based on animal studies diazepam and phenobarbital prevented convulsions. Due to the slow elimination of the active compound and its metabolites, the treatment must be continued for several days, gradually decreasing the dose of anticonvulsant based on the clinical response.
